The change in Mr. Pun Chi Tung Melvyn's interest is a consequence of the: (i) vesting of 1,700,000 share awards out of the remaining share awards of 1,700,000 granted to him on 4 April 2022 pursuant to the Yoma Performance Share Plan (the "Yoma PSP 2015") and approved by shareholders at the Annual General Meeting of the Company held on 27 July 2023 (the "2023 AGM"). Following the vesting of 1,700,000 share awards, the total of 5,000,000 share awards granted to Mr. Pun Chi Tung Melvyn on 4 April 2022 pursuant to the Yoma PSP 2015 have been fully vested; and (ii) vesting of 660,000 share awards out of the remaining share awards of 1,340,000 granted to him on 28 May 2023 pursuant to the Yoma PSP 2015 and approved by shareholders at the 2023 AGM. The 4,000,000 options granted to Mr. Pun Chi Tung Melvyn had been forfeited during the financial year ended 31 March 2025. The percentage of shares immediately before the change is calculated based on the total number of issued shares of the Company of 2,388,836,260 shares (excluding treasury shares). The percentage of shares immediately after the change is calculated based on the total number of issued shares of the Company of 2,398,804,260 shares (excluding treasury shares).
