The change in Professor Koh Annie's interest is a consequence of the: (i) vesting of 84,000 share awards out of the remaining share awards of 84,000 granted to her on 28 November 2021 pursuant to the Yoma Performance Share Plan (the "Yoma PSP 2015") and approved by shareholders at the Annual General Meeting of the Company held on 29 January 2021. Following the vesting of 84,000 share awards, the total of 250,000 share awards granted to Professor Koh Annie on 28 November 2021 pursuant to the Yoma PSP 2015 have been fully vested. (i) vesting of 238,000 share awards out of the remaining share awards of 238,000 granted to her on 28 May 2023 pursuant to the Yoma PSP 2015 and approved by shareholders at the Annual General Meeting of the Company held on 27 July 2023. Following the vesting of 238,000 share awards, the total of 700,000 share awards granted to Professor Koh Annie on 28 May 2023 pursuant to the Yoma PSP 2015 have been fully vested. The percentage of shares immediately before the change is calculated based on the total number of issued shares of the Company of 2,401,997,260 shares (excluding treasury shares). The percentage of shares immediately after the change is calculated based on the total number of issued shares of the Company of 2,408,499,260 shares (excluding treasury shares).
